#### **About the Aire Rivers Trust**

We are the only charity dedicated to improving the health and resilience of the River Aire and its catchment. We work with communities, landowners, local authorities, and partners to restore habitats, enhance biodiversity, and create a sustainable river environment for both people and wildlife.

Our work includes river restoration, community engagement and climate adaptation projects across the Aire catchment. We are now embarking on an ambitious **Wetland Creation Programme** delivering for biodiversity, climate resilience and people across the catchment.

#### Purpose of the Role

The Programme Manager will lead the planning and delivery of the Aire Rivers Trust's **Wetland Creation Programme**, overseeing the successful development, planning and implementation of multiple projects to create and restore wetland habitats across the catchment.

The postholder will:

- Provide strategic leadership and coordination across a portfolio of wetland projects.
- Lead the partnership between us and the Yorkshire Wildlife Trust.
- Line manage and support two Project Managers.
- Maintain oversight of project management processes, ensuring high standards of delivery, reporting, and stakeholder engagement.
- Contribute to the strategic development of our wider environmental and catchment management work.

## **Programme Leadership**

- Lead the design, coordination, and delivery of the Wetland Creation Programme, ensuring it meets ecological, social, and financial objectives.
- Develop and maintain a detailed programme plan, identifying dependencies, risks, and opportunities.
- Work with colleagues to align activities with our strategic plan and funding commitments.
- Act as the main point of contact for programme-level partners, funders, and regulatory bodies.

#### **People and Project Management**

- Line manage two Project Managers, providing mentoring, support, and performance management.
- Promote best practice in project delivery, risk management, and reporting.
